This rate schedule applies to CSI's "Personal and Private Use" accounts, which are for individual investors who use CSI's Unfair Advantage® (UA) software for data retrieval. This software offers substantial data management and analysis capabilities and this type of account meets the needs of most individual investors. No sharing, networking or business use is permitted. ### Personal and Private Use Pricing

**Access to five (5) years of historical data is provided for each selected category upon subscription.**

Each month of daily updates extends the accessible history by one additional month beyond your history's initial start date.

Each of our offerings for Personal and Private Use customers includes a very liberal cap on the maximum number of markets that may be processed through Unfair Advantage's portfolios or API on any given day. These limits are well beyond the expected use of this product by individual investors and analysts. For auditing purposes, a "market" is defined as a specific commodity or other similar tradable offered by an individual exchange, such as LME tin or CBT corn. These limits do not prevent you from exploring any of the markets involved your update categories, as long as the cumulative daily total doesn't exceed the stated caps.
