NEW STOCK ADDITIONS TO DATA BASE: CSI has added many new stocks to the data base, and we plan to offer the entire New York Stock Exchange. If you wish to collect any stock information and you are in doubt about whether we offer it, (1) please call our Customer Service Department, and we will be happy to consider your request. The cost of stock data is exactly one-half the cost of commodity contracts. In other words, two stocks or two options on commodities or stocks can be obtained for the same price as one commodity contract.

WELCOME TO FORMER CONTI USERS!: Brokers with Conti Commodities and many Conti customers who previously drew their data from the "de-commissioned" Conti Commodities Research Center are now customers of CSI. Conti no longer provides such data services to the commodity industry. We regret losing such a visible competitor, but we are happy to accept these new customers. We wish to welcome the Conti brokers and Conti customers.

The newcomers have found the CSI service to be lower in price, with other advantages not offered by Conti. Stan Ehrlich, a Conti broker, asked that CSI notify customers that he has a Cycle Finder Tool, which Stan says is useful to predict market direction. 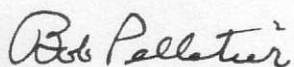
QUICKTRIEVE 3.0 RELEASE: The 3.0 release for the Apple is becoming more stable and customers are enjoying the corrections to the Move and Quickplot programs. Customers have called to advise us that they are impressed with the hundred day per second loading speed of the Quickplot program, as well as the added capability with moving averages and an RSI calculation. Users can plot price, volume and open interest simultaneously on the same graph and can piece together many printouts of the screen image -- all with the same scale -- to produce long term charts.

ERROR REPORT: Our enclosed Error Report, which identifies only five errors from the month of July, is comparable in length to the June Error Report. New procedures instituted here at CSI have practically eliminated errors from our data release. Our goal is to reach zero errors per month.
