"Just a brief note to absolutely rave about the new [Apple 4.0 Quick software]!! It's spectacular! I've explored a large number of the menu items and it's like having my ultimate wish list come true. Three or four times I've nearly fallen off my chair...Not only have you instituted nearly all my suggestions, which still has me shaking my head with astonishment (THAT's SERVICE!!), but the host of other improvements has to make QT among the best, if not the best total package of communications/ charting/analysis/data management available. QT is competing with the \$2,000 to \$3,000 packages, and in most respects blowing them off the map! CSI'S QUICKPC HARDWARE - COMPATIBLE WITH IBM XT

For CSI to upgrade its computer facilities, we are purchasing 40 IBM PC compatibles for use in the office by some of our personnel. We found that by dealing in larger unit quantities, we could put these machines together at a cost of less than half of what customers would have to pay at a retail computer outlet. At a computer store, an IBM XT with a modem would cost in the neighborhood of \$4,000 plus tax. CSI may be willing to provide a compatible equivalent for between \$1,295 and \$1,795 to our customer base, depending upon the results we obtain from the enclosed survey and the equipment requested. For \$1,795, plus shipping charges, a user would be able to purchase a compatible PC with 256K of memory, a 5-megabyte hard disk, a color graphics adapter, a monochrome monitor, one floppy disk drive, a printer and a 300 baud modem. The speed of this compatible PC would be approximately 33% faster than the IBM XT, because we use a faster processor chip. Before we commit to supplying these computers to customers or prospective customers on a long-term basis, we want to review the results of our survey.

If you decide you might wish to purchase one of these machines from CSI in precisely the way in which it is configured with or without modem, printer, or monochrome display, then send the enclosed survey form back to CSI with your invoice. only sell to non-Florida, USA, residents. It is not the responsibility of the seller to collect sales tax for out of state purchasers therefore CSI will not impose a sales tax. Foreign residents, due to possibly different electrical requirements, will not benefit from the 30 day warranty. and purchase will be at the sole risk of the foreign purchaser. The compatible PC is totally generic new merchandise and holds the brand name - CSI QUICKPC. Please allow one to four weeks for delivery. From the \$1,795 purchase price, you may deduct \$100 each, if you wish to exclude the printer or the monitor. Deduct \$150 if you wish to exclude the 300 baud modem and deduct \$150 if you wish to substitute a second floppy disk in place of the 5MB hard disk. Add \$100 if you wish to have second floppy disk in addition to the hard disk.

One of the problems with purchasing a computer by mail is the maintenance requirements. Should CSI offer these computers at this price, a 30 day warranty would be provided and any repair required after the warranty period would be made by CSI at a maximum cost of \$195 per failure but no less than \$100, for at least three years after the purchase date, regardless of the problem. The only obligation the customer would have to make the computer work for his own use would be to purchase a \$65 IBM DOS Disk from his computer store. CSI will provide the IBM DOS disk for an additional \$75.00. CSI QUICKPC quantities may be limited at these prices. If you are definitely interested, please call CSI Marketing. maintain a homogeneous family of like-sounding software products, we decided to re-name our On-Line Profile and Super On-Line Profile with the title "QUICK-DAYTRADER". We have several users on-line now with QUICKDAYTRADER, and customers have reported favorable experiences. Since it began operating in July, the data delivery has been very smooth, and very few problems have arisen. The QUICKDAYTRADER currently operates from 8:30 AM until 3:00 PM, but a user can access data for any day in the past three weeks. We hope to extend the on-line hours to 4:15 PM when the financial markets close. This will not be accomplished until late September, however,

QUICKDAYTRADER users of CBOT commodities will have their \$20 exchange fee paid for by CSI out of regular access fees for the profile service until further notice. We made this decision to cover a maximum of \$20 in fees to make CSI's service the most affordable. Should the results of negotiations with the CBOT require otherwise, no fees for service prior to such agreement will be imposed on the customer. We will keep you appraised of any changes in this policy.

We have told customers who have an interest in the CBOT Liquidity Data Banktm (LDB) that this supplementary service to the CBOT Market Profiletm is only available after the fact after the markets are closed. Consequently, no decisions today can be made which employ this volume information. Pete Steidlmayer, a CBOT director, has told CSI that his use would primarily center around the CBOT Market Profile data and that this was most important to him. Since he developed the system we have relied heavily on his opinion and have not given as much emphasis to the LDB service.

A user of our 15 minute profile data feed has told CSI that the information content of the 15 minute profile makes the product worthwhile. He far preferred the 15 minute feed over the 30 minute data feed. #

WP have received many very positive responses from customers concerning our QUICKQUOTE capability. Many foreign users are taking advantage of this product where quote services are very expensive. Most Susers are traders who need to call their broker once or twice a day to request quotes on one market or the other. cost per quote for QUICKQUOTE users accessing in the middle of the day runs in the neighborhood of \$.05 to \$.25, oper Open-High-Low-Last reading, depending" on the numbers of quotes requested per call. Users of QUICKQUOTE are issued a second User ID but pay rates that are only 30% of current daily prices. We hope to have more exciting announcements concerning the QUICKQUOTE product in our next letter.#
