MANY PROJECTS UNDERWAY AT CSI

Many areas of development are underway at CSI and we thought you might like to know what we are up to.

<u>Hardware Additions</u> - We are improving our main frame hardware to accommodate more disc capacity, more access ports and speedier file creation. We are also adding a facility to access history on a live basis without complex ordering procedures.

Expanding Data Base - As you may know, we offer all commodities and commodity options traded in the U.S. and all important overseas series. We also offer all NYSE stocks, many American, most mutual funds, and a large number of over the counter items. We will add anything you might wish to quote on a daily basis.

The timeliness of our data release is superior to any other supplier with an availability only minutes after final exchange settlements are posted.

QUICKTRIEVE^R Release - The new QUICKTRIEVE (version 4.0) release is proceeding very nicely. Multi charts can be displayed at once with far more history availability. The new software is much improved and a new professional style manual is being developed.

<u>QUICKMONEY</u>^R - Work on this product continues with many problems behind us. We look forward to beta testing in the near future.

UNFAIR ADVANTAGESM - Here is a new CSI product which we hope to tell you more about in the next month or two. It follows futures, stocks and mutual funds in an unusual way, producing a higher than normal likelihood of smaller, but consistent profits. It uses game theory strategy to place your opponent (the market) at a disadvantage, and requires knowledge of your risk capital to do the best possible job. As an active trading tool, the design of this product should also help develop your trading confidence.

In taking care to notify customers first of any new or impending products, we got into trouble by announcing QUICKMONEY long before it was ready for release. At the risk of repeating the same error with UNFAIR ADVANTAGE, we are now simply letting our users know that we have another product on the drawing board which we hope to release in the near future. There is a difference however. The effort of developing UNFAIR ADVANTAGE is much further along because it has been on our drawing board for many months. We will soon begin advertising this product on an inter-state basis to preserve the trademark.

HARDWARE DIFFICULTIES CAUSE DELAY

After many months of timely data release, on April 13th and April 18th we did not deliver all data until late in the evening. The problem on April 13th stemmed from the simultaneous loss of the directory track on two large disc drives. In making room for a new system installation designed to increase the number of network access ports, expand disk capacity, and simplify the overall configuration, a cable on the system to be replaced became damaged. The damage caused the loss of certain addressing information for two disk drives.

The April 18th problem, was a less serious procedural failure that nevertheless caused inconveniences for our customers. We apologize for these two incidences and we hope never to repeat them.

FOREIGN NETWORK ACCESS

An improvement in the access procedure for network use is planned in conjunction with the impending new release of QUICKTRIEVE version 4.0. We ordered a series of special ID's for each country and we are still awaiting receipt.

In response to last months request, we have received input from users concerning local PTT access costs. If you haven't responded, your input would be helpful. We hope to get this more convenient accessing procedure in place to simplify foreign access through at least two network alternatives.

LONDON ACCESS FOR COMPUNET - On May 6, 1989 the number for Compunet (CSC) in London, England will be changed to 01-439-7537.

FOREIGN ACCESS CODES AND PRICING CHANGES

Effective June 1st, 1989 the Compunet user ID through CSC will be changed. Any user who wishes to continue this service should immediately notify us of your wishes so that we can either supply you with the new access code or mail you a new QUICKTRIEVE disk. Beginning with June 1st any user who uses Compunet (CSC) or the new Telenet accessing method with an NUI supplied by CSI, will be subject to a new graduated price list that is

a function of the number of commodities or stocks accessed. The new price list will be supplied at that time

NOTES FROM CUSTOMER SERVICE

STOCK ITEMS WITH CSI NUMBERS LARGER THAN 6000 cannot be ordered using the Customer Subsystem through selection (A) Change User Portfolio and (B) Order Historical Data. These items must be requested through the selection (C) Enter Message for CSI. Please indicate the stock number and the symbol, along with the starting and ending date for ordering history.

THE PRINT CONTRACT FILE (G) on the QUICKMANAGER menu selection offers the user two options: first, you may take the data in your QUICKTRIEVE format files and create ASCII format data files. This makes your QUICKTRIEVE files compatible with the LOTUS spread sheet program or other software requiring ASCII format files. Secondly, and most obviously it will instruct your printer to print out a specified contract.

WHEN ORDERING HISTORICAL DATA through the (G) Customer Subsystem <u>please</u> include a message to our customer service department suggesting a specific file number for history collection. This will eliminate the need for you to call customer service to obtain the file number we would arbitrarily assign or wait for your daily collection to receive an incoming message informing you of the file number we assigned.

HISTORY ORDERS PLACED THROUGH THE CUSTOMER SUBSYSTEM during regular business hours 8 AM to 10 PM should be ready in a two hour period. Orders placed after 10 PM will be ready by 9 am.
