QUICKTRIEVE[®] AND QUICKMANAGER[®] UPDATE

We have been quietly rewriting QUICKTRIEVE and QUICKMANAGER to improve usage, add capability and simplify the manual. The new product will be assembled in a commercial quality reference manual and will be customized for each user. All popular formats will be supported.

A few copies have been distributed on a beta test basis. Next month we will know more on the cost and exact timing of this new release.

QUICKPLOT[®]/QUICKSTUDY[®] (4.0)

The new release of QUICKPLOT and QUICKSTUDY incorporates fast, functional and precise graphics that, in our opinion, rivals anything available elsewhere. The enclosed two pages of charts show two screen dumps from a VGA screen image.

You can get from one to seven related images on the screen at one time. Any of the smaller images can be arranged in a full screen blow up.

The images shown are presented without grids and price/volume tick marks, but the finished product will have these features in place. We remain in the development mode. The images are presented to give you some idea of how we are progressing. Notice the nicely arranged price or volume increments which are automatically optimized for easy viewing and image maximization.

Next month we should know more about when this revised product can be released.

Copper, CSI #6, symbol CP is expiring in December. The 12/89 contract is the only active contract at this time.

High Grade Copper, CSI #8, symbol HG is trading on the COMEX Exchange. The active months are 1, 3, 5, 7, 9, and 12. This newer grade copper is more compatible with the London Metal Exchange copper contract for wire bars.

To modify your commodity constants file to accept the new High Grade Copper information, enter QUICKMANAGER and select (E) Enter Editor Subsystem, then select (C) Edit Commodity Constants File. Enter the number eight (8) and press ENTER. Unless you have a new copy of QUICKTRIEVE, Shelled Eggs (formally CSI #8) will appear. Replace shelled eggs with the information below and then press escape (ESC) to save the file.

The scientific notation requirement of QUICKTRIVE would require a raw open interest value of 294070, for example, to be stored as 129407. A volume or open interest of magnitude 99999 or less requires no adjustment.
